



## Direct Deposit/ Electronic Funds Transfer Enrollment

***If you have not previously elected to do so***, please take this opportunity to participate in our Direct Deposit program. This program is part of our continuing effort to provide the best customer service to our owners. Some benefits of our direct deposit are the elimination of mailing delays, lost or stolen checks and receipt delays related to address changes. Direct Deposit will allow you to receive an electronic funds transfer (EFT) into your designated financial institution (bank, credit union or savings and loan) at no cost. The EFT will deposit the cash value of your monthly royalty payment into your bank account and is available for use two (2) business days following the check issue date using the Automated Clearing House (ACH) wire system. It is faster, convenient and more efficient, plus, no more waiting to receive your check.

***If you elect not to participate in our Direct Deposit program, simply disregard this letter. No further action on your part is necessary.***

If you choose to continue receiving checks by mail, please allow 15 business days for your check to arrive before submitting a request to reissue your payment.

Such owner further agrees that authorization of EFT (electronic funds transfer) as evidenced by the signature below amends your existing payment instructions to us and such authorization will remain in effect until otherwise canceled by you by way of written notification to PetroTx Operating, LLC.
